ORDER FINALIZING THE  
WYOMING UNIVERSAL SERVICE FUND ASSESSMENT LEVEL  
FOR THE JULY 2017 TO JUNE 2018 FISCAL YEAR NUNC PRO TUNC  
(Issued November 16, 2017)

On July 12, 2017, the Wyoming Public Service Commission (Commission) issued its *Order Finalizing the Wyoming Universal Service Fund Assessment Level for the July 2017 to June 2018 Fiscal Year* (Final Order) in the above docketed matter. Ordering Paragraph 1 of the Final Order states:

Pursuant to Commission action taken on May 3, and June 29, 2017, the Wyoming Universal Service Fund assessment level, effective for the twelve-month period beginning July 1, **2016**, and on a final basis, is established at 1.40 percent (1.40%) of gross intrastate retail telecommunications revenues.

Due to a typographical error, the language in Ordering Paragraph 1 erroneously reads the Wyoming Universal Service Fund assessment level, is effective for the twelve-month period beginning July 1, 2016, when it should have read July 1, **2017**. The Commission has therefore determined it is in the public interest to correct Ordering Paragraph 1 of its *Final Order*.

IT IS THEREFORE ORDERED:

1. Pursuant to Commission action taken on May 3, and June 29, 2017, the *Order Finalizing the Wyoming Universal Service Fund Assessment Level for the July 2017 to June 2018 Fiscal Year* is hereby corrected as follows:


1. Pursuant to Commission action taken on May 3, and June 29, 2017, the Wyoming Universal Service Fund assessment level, effective for the twelve-month period beginning July 1, 2017, and on a final basis, is established at 1.40 percent (1.40%) of gross intrastate retail telecommunications revenues.

2. The *Order Finalizing the Wyoming Universal Service Fund Assessment Level for the July 2017 to June 2018 Fiscal Year* entered on July 12, 2017, will otherwise remain in full force and effect, except as corrected herein.


