Deadline to complete all discovery. <i>All responses are due within 5 business days of receipt.</i> (See paragraph 4)	September 27, 2017, by 5:00 p.m.
Deadline for parties to exchange exhibits	October 6, 2017
Deadline for parties to file any pre-hearing reports, pre-hearing motions, any objections to pre-filed testimony and exhibits. Deadline to file exhibits, and exhibit index (see paragraphs 3 and 5)	October 10, 2017, by 3:00 p.m.
Pre-hearing Conference (see paragraph 5)	October 17, 2017, at 10:00 a.m.
Exhibit Conference	October 25, 2017, at 8:30 a.m.
Public Hearing 2 days	October 25, 2017, at 9:00 a.m.

2. All other aspects of the *Scheduling Order* issued on May 8, 2017, remain in full force and effect.

3. This *Amended Scheduling Order* is effective immediately.
