

PUBLIC NOTICE

Pursuant to the Wyoming Administrative Procedure Act and the Wyoming Public Service Commission's (Commission) Rules, notice is hereby given that a public hearing is scheduled regarding the Applications of [i] Phillips 66 Pipeline LLC (Phillips 66), requesting authority to cancel its Wyoming PSC Tariff Nos. 3.0 and 4.0; [ii] Pioneer Pipe Line Company (PPLC), requesting authority to cancel its refined products pipeline Tariff Wpsc No. 12.0; and [iii] the intervention of Sinclair Oil Corporation (Sinclair). **The public hearing is set to commence on Tuesday, April 3, 2018, at 9:00 a.m., in the Commission's hearing room located at 2515 Warren Avenue, Suite 300, in Cheyenne, Wyoming.**

Phillips 66 and PPLC are public utilities, as defined in Wyo. Stat. §37-1-101(a)(vi)(G), subject to the Commission's jurisdiction pursuant to Wyo. Stat. §37-2-112.

On February 16, 2017, Phillips 66 filed its Application in Sub 32, requesting to cancel Wyoming PSC Tariff Nos. 3.0 and 4.0. On June 7, 2017, the Commission issued its *Order (Order)* in Sub 32 approving the Company's Application to: [i] cancel Tariff Nos. 3.0 and 4.0 relating to the transportation of refined products; [ii] remove Cover Letter dated April 6, 2012; and [iii] remove Supplement No. 1 to Tariffs 2, 3, 4, 6 and 7.

On June 6, 2017, PPLC filed its Application in Sub 4 requesting authority to cancel its intrastate transportation tariffs, PPLC Wyoming P.S.C. No. 12.0 (Tariff 12.0), effective July 1, 2017, because in Sub 32, the Commission found "the transportation of refined petroleum products (namely gasoline) by a pipeline is not an activity within the scope of Wyo. Stat. § 37-1-101(a)(vi)(G)." PPLC stated that if the Commission approved its Application, it would continue to ship gasoline as a product, but that it would be shipped via a FERC tariff or a PPLC rate sheet.

On July 7, 2017, Sinclair filed its [i] *Petition For Rehearing, Protest and Request for Intervention and Hearing*; and [ii] *Petition for and Notice of Intervention and Objection of Sinclair Oil Corporation (Petitions)* in the above referenced dockets.

By *Order* issued January 31, 2018, the Commission consolidated the above referenced dockets and granted Sinclair's intervention and request for hearing

All interested persons are encouraged to attend the public hearing which will be conducted in accordance with the Wyoming Administrative Procedure Act and the Wyoming Public Service Commission Rules. Interested persons may appear and be heard, either in person or through counsel, as provided by Commission Rule.

The Commission's hearings are open to all persons.
